"U.S. GOVERNMENT XEROXES RUSSIA'S USE OF PSYCHIATRIC EXAMINATION TO PUNISH AND SILENCE DISSIDENTS", SAYS THE GUERRILLA ART ACTION GROUP, WHICH WILL PRESENT AN INFORMATION BOOTH AT THE AVANT-GARDE FESTIVAL:

## "UNITED STATES OF AMERICA VS. ARTIST JEAN TOCHE"

Artist Jean Toche, who was arrested on March 31, 1974, for allegedly sending to various museums, newspapers and individuals in this city 30 handbills, which strongly criticized various policies of those museums, has been ordered by Federal Judge Kevin Duffy, at the request of the U.S. Government, to undergo a psychiatric examination (Opinion N° 41284, of October 8, 1974).

Toche was charged with allegedly sending a so-called "kidnap threat" through the mails. The government alleges that on the basis of that act, and because Toche picketed the Metropolitan and other major museums in "an attempt to disrupt the normal course of business", and because he is accused by the Metropolitan of having allegedly "released\_cockroaches\_onto\_the\_dinner\_table\_during\_a\_banquet" at that museum, that Toche is suffering from mental disorder.

Attorneys for the defendant, Margaret Ratner, joined by Michael Ratner, William Kunstler of the Center for Constitutional Rights, and Eve Carey of the New York Civil Liberties Union, are at a loss to find any criminality, based on the expression of constitutionally-protected rights, and see the danger of a government-imposed psychiatric examination as a grave threat to the Bill of Rights.

Artist Jean Toche has not been indicted. He has been denied DE FACTO a preliminary hearing where he could disprove all charges against him, but Judge Duffy has accepted at face value all the accusations of the government and of the Metropolitan Museum, and on the basis of those charges, has ordered a psychiatric examination. This examination is not only a threat to all of us, creating a chilling effect on future dissent against museums, but will imprint for life a stigma on Toche's reputation, both as an artist and as human being (police records, jobs, credit rating...). Attorneys for the defendant are appealing the judge's decision.

Artist Jean Toche and the Guerriilla Art Action Group will be at the information booth from noon to 4:00PM, on November 16, to answer questions and invite public participation and discussion on the issues involved.
